Now you are seen suppressing documents that incriminate the criminals who used you to do it.

#### Warrants in the capital crimes proceeding are as follows;

- 1. <u>Congressional</u>;
- 2. War Crimes;
- 3. Class Action;

If you are reading this your name is ready to go on all three of the lists.

Your editorial department masthead is a duplicate of the indictment list in this high crimes action.

Over the next hundred days, the investigation, in collaboration with agency oversight are in prep for a high crimes trial on the scale of Nuremberg.
